

Helpful Viewing Tips

Check Order Summary and Status: Log into the system with your user name and password.

A. To review the status of orders:

- Select “User” from the top navigation menu
- Select “Service Requests”
- Select “Any Status” and click “Search” to view all orders.

B. To review completed orders:

- Select “User” from the top navigation menu
- Select “Tracking”

Check Invoice (s). After the work has been performed, you will have access to view your invoice(s) after the 8th of the month following completion of work :

- Select “User” from the top navigation menu
- Select “Invoices” and enter a date range to filter
- Select the hyperlinked invoice number or “Regenerate PDF” to view the invoice

{1} Create Account/Log In

First Time Users Go To: <http://researchcores.partners.org/account/new>

Internal User:

- Enter your Partners user ID and select “Lookup Information”.
- Review/Update user information and select “Create Account”.

External User:

- Select “Don’t have a Partners ID?”
- Complete the requested information and select “Create Account”. (Your e-mail address will be used as your username)

{2} Enter Payment Type

Prior to placing a request users must enter payment information. This information will be linked to an individual's username and available each time a request is placed.

Select “PHS” or “Non-PHS” from the “Payment Type” dropdown menu.

PHS User:

- Enter 6-digit fund number and select “Lookup Information”. Review populated information to insure correct fund is being used.
- Select “Assign Fund”.

Non-PHS User:

- Select “PO Number” or “Check” to identify payment option.
- Complete requested information and select “Assign Fund”.

To review, edit or add new funds select “User” - > “Funds” from the top navigation menu.

{3A} Place A Service Request

To place a request first navigate to the Core you wish to utilize. All Cores can be found by clicking on the “Cores” menu from the top navigation menu.

Service Request (s)

- Select “Service” on the left navigation menu to view the list of available services and their charges.
- Select “Request Service” appearing to the far right of each service.

{3B} Place An Equipment Request

Equipment Request (s)

- Select “Equipment” on the left navigation menu to view the list of available equipment, pre-requisite to use requirements and their charges.

To Schedule Pre-Requisites (typically training)

If pre-requisites are required they will need to be fulfilled before being allowed to schedule use of the equipment.

- Click on the “Training” link to request training.
